We are committed to protecting the privacy and personal data of our players, parents, guardians, and website visitors. Because we train minors, we treat all collected information with the highest levels of security and confidentiality. This policy outlines how we collect, use, and protect personal data in compliance with **UAE Federal Decree-Law No. 45 of 2021 on Personal Data Protection (PDPL)**.

1. Information We Collect

We collect personal information directly from parents or legal guardians during registration, through our contact forms, or during our club operations. This includes:

- **Parent/Guardian Details:** Full name, email address, phone number, and home address.
- **Player (Minor) Details:** Full name, date of birth, gender, and school details.
- **Health & Safety Data:** Relevant medical history, allergies, or physical conditions to ensure player safety during training.
- **Technical Website Data:** IP addresses, browser types, and cookies collected automatically when you browse our website.

2. How We Use the Information

We use the collected data strictly for operational, safety, and legal purposes, including:

- Processing club registrations and managing training rosters.
- Communicating schedules, venue changes, and urgent club updates.
- Ensuring the health and safety of players by informing coaches of relevant medical conditions.
- Responding to enquiries sent through our e-mail address.

3. Payment Data Handling

We do not process or store credit or debit card details on our website.

4. Media, Photographs, and Videos

We love celebrating our players' achievements! However, we respect your family's privacy:

- **Consent Required:** We will only publish photographs or videos of players on our website, social media channels, or marketing brochures if we have received explicit, written consent from a parent or legal guardian.
- **Right to Withdraw:** Parents have the right to withdraw their media consent at any time. Upon receiving a written request, we will promptly remove the relevant images or videos from our digital platforms.

5. Third-Party Tools (Google Forms)

We use Google Forms to manage player registrations and collect sign-up details.

- **Data Processing:** When you submit a registration form, your data is securely transferred to and stored within our Google Workspace account.
- **Security:** Google employs industry-standard data security and encryption measures.
- **Control:** Only authorized personnel can access this information. Google does not use your personal details for its own marketing purposes.

6. Data Sharing and Third Parties

We do not sell, rent, or trade your personal data. We only share information with third parties under the following strict conditions:

- **Emergency Medical Services:** If a player requires urgent medical attention, we will share health and contact details with medical professionals.
- **Governing Sports Bodies:** If required for official tournament registrations or league licensing within the UAE.
- **Legal Obligations:** If requested by UAE law enforcement or regulatory authorities.

7. Data Security and Retention

We implement robust technical and organizational security measures to protect your data from unauthorized access, loss, or disclosure. Data collected through our website is stored on secure servers. We only retain personal data for as long as the player is active with our club, or as required by UAE legal and financial record-keeping regulations.

8. Your Legal Rights

Under the UAE PDPL, parents and guardians hold specific rights regarding their family's data. You have the right to:

- Access the personal data we hold about you and your child.
- Request the correction or updating of inaccurate information.
- Request the complete erasure of your data when your child leaves the club.
- Object to or restrict certain types of data processing.
